My suggestion is we cleanly wrap this up after the Great Repeal and undergo a smooth transition onto your next project with the grateful thanks of the R for a successful academic experiment. No names at all will be on the bills, which go open source. Your articles will be quietly unpublished over the next few weeks one-by-one and you can republish them elsewhere. The R social media can go to someone without knowledge of this to just run articles, and there will be no mention of you on it; nor any mention of the R by you other than your grateful nostalgia. No great fanfare, just a gentle fading away. You will not publish again on the R at all or get any cross-promotion. No bad chatter, disparagement, or further problems.
